**NOTIFICATION**

The 25<sup>th</sup> August, 1971

No. 9859-V-DP-71/3654- In exercise of powers conferred by the sub- section (i) of section 4 of the Punjab Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act, 1963, the Governor of Haryana is pleased to declare the area at Hisar specified in the schedule below and shown in the Plan appended hereto, to be controlled area for the purposes of said Act, namely:-

**SCHEDULE**

- North:** Starting from the inter section point of the Katcha rasta from village Kureri and the southern boundary of Hisar Distributory viz point 'A'; thence towards east along the southern boundary of Hisar Distributory upto the boundary of Government Live Stock Farm; thence all along the Government Live Stock Farm boundary upto the point 'B' where it meets the municipal boundary; thence all along the municipal boundary upto the north-eastern corner of Textile Mill; thence towards north along the eastern boundary of Government Live Stock Farm up to the point where it meets the katcha rasta to village Dhanshu and thence along the Katcha rasta upto the Dhansu village boundary; thence towards south-east along the south-western boundary of village Dhanshu and south-western boundary of village Mirzapur meeting the south eastern boundary of railway line to Jakhal; thence towards north-east along the south eastern boundary of railway line upto the inter section point of the railway boundary and Katcha rasta from village Mirzapur viz point 'C'.
- East:** From point 'C' towards south-east along the Katcha rasta to village Mirzapur along its western and southern boundary of abadi deh and thence along katcha road from village Mirzapur to village Niyana upto the point where it meets the eastern boundary of village Mirzapur; thence along the eastern boundary of village Mirzapur and Shikarpur upto the point where it meets to the balsamand distributory; thence towards south along the eastern boundary of village Shikarpur, Raipur and Satrod kalan upto a point where it meets the southern boundary of railway line to Rewari viz. point - 'D'.
- South:** From point 'D' towards west along the southern boundary of railway line from Rewari upto the eastern boundary of Balsamand distributory; thence towards south along the eastern boundary of Dewa minor upto Southern boundary of Petwar minor; thence along the southern boundary of Kaimri minor and meeting the western boundary of metre gauge railway line from Bikaner; thence towards north-east along the north western boundary of railway line upto Katcha rasta from village Ganguwa and further along the Katcha rasta and along the northern boundary of abadi deh of Ganguwa going towards west to Kureri meeting the road from Balsamand viz point 'E'.
- West:** From point 'E' along the north-eastern boundary of abadi-deh Kureri meeting Katcha rasta to village Lodas; thence towards north along the katcha rasta to village Lodas upto the starting point 'A'.
