No. J.D.-92/C.A. 5/458 .-- In exercise of the powers conferred by sub-section (i) (b) of Section- 4 of the Punjab Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act, 1963, the Governor of Haryana is pleased to declare the area around Government High School, Primary Health Centre, Agroha Vikas Trust and Mound as specified in the Schedule given below and shown in the plan appended hereto to be Controlled Area for the purpose of the said Act, namely:-

Schedule of boundary of Controlled Area Around Government High School, Primary Health Centre, Agroha Vikas Trust and Mound to be read with [Drawing No. DTP(H) 1916/89, dated 3rd January, 1989].

SCHEDULE

- North:--** Starting from point 'A' i.e. the North-Western Corner of rectangle No. 85 of Agroha, thence towards East along the Northern boundary of rectangle No. 85, 84, 83, 82, 81, 80, 79 and 78 of village Agroha upto the point 'B' i.e., where it meets, the Western revenue boundary of village Mirpur, thence towards South along the Western revenue boundary of village Mirpur up to the point 'C' i.e. the South-Western corner of rectangle No. 30 of village Mirpur up to Point 'D' i.e. the North-Eastern corner of rectangle No. 34 of village Mirpur.
- East:--** Thence towards South along the Eastern boundary of rectangle No. 34 and 47 of village Mirpur up to point 'E' i.e. the South-Eastern corner of rectangle No. 47, thence towards East along the Northern boundary of rectangle No. 55 of village Mirpur, up to point 'F' i.e. the North-Eastern corner of rectangle No. 55, 70, 76 and 92 of village Mirpur upto point 'G' i.e. where it meets North-Eastern boundary of village Agroha, thence towards South East along the eastern boundary of village Agroha, up to point 'H' i.e. the South-Eastern corner of rectangle no. 194 of village Agroha.
- South:--** Thence towards West along the Southern boundary of rectangle No. 194 and 193 of village Agroha up to point 'I' i.e. the South-Western corner of rectangle no. 193 of village Agroha. Thence towards South along the Eastern boundary of Rectangle no. 197 and 218 of village Agroha up to point 'J' i.e. where it meets the Southern boundary of village Agroha up to point 'K' i.e. where it meets the Eastern boundary of N.H. 10, thence towards West across the above-said road along the Southern boundary of rectangle No. 218, 217, 216 and 215 of village Agroha up to point 'L' i.e. the South-Western corner of rectangle no. 215 of village Agroha, thence towards South along the Eastern boundary of rectangle No. 224 of village Agroha up to point 'M' i.e. the South-Eastern corner of rectangle No. 224 of village Agroha, thence towards West along the Southern boundary of rectangle No. 224 of village Agroha, rectangle no. 3, 2 and 1 of village Resalu Khera and rectangle No. 4, 5, 6 and 7 of village Faransi up to point 'N' i.e. the South-Western corner of rectangle No. 7 of village Faransi.
- West:--** Thence towards north along the Western boundary of rectangle no. 7 of village Faransi up to point 'O' i.e. where it meets the Eastern boundary of village Khasa Mahajan, thence towards East along the village boundary of Khasa Mahajan up to the point 'P' i.e. the Trijunction of village boundaries of Khasa Mahajan, Faransi and Agroha, thence towards North along the Western boundary of village Agroha up to the point 'A' i.e. the point of start.
