No. CCP(NCR)/HSR/TLWD-R(CA)2007/4242.--- Where in the opinion of the State Government the area specified in the Schedule given below and shown in the plan appended hereto has the potential for building activities, industrial, commercial, institutional and recreational estates/activities and uses subservient to the above ;

Now, therefore, in exercise of the powers conferred by sub-section (i) of Section 4 of the Punjab Scheduled Roads and Controlled Areas Restriction of Unregulated Development Act, 1963 (Punjab Act 41 of 1963), the Governor of Haryana hereby declares the said area to be a controlled area for the purpose of the said Act, namely:-

SCHEDULE

Schedule of boundaries of the controlled area around village Durjanpur, Chikanwas and Landhari, tehsil and district Hisar to be read with drawing No. D.T.P.(H) 3430/2007, dated the 7th August, 2007.

North:-- Starting from point 'A' which is the north-west corner of rectangle No. 223 of village Agroha (Hadbast No. 54) thence towards north along the controlled area boundary of Agroha which is already declared vide Haryana Government Gazette notification No. JD-92/HCA/5/458 dated the 30th April, 1992, published on 19th May, 1992 upto point 'B' which is north-west corner of rectangle No. 1 f village Landhari (Hadbast No. 140) thence towards east along village revenue boundary of village Landhari (Hadbast No. 140) upto point 'C' i.e. north-east boundary of rectangle No. 5 of village Landhari (Hadbast No. 140).

East:-- Thence moving from point 'C' towards south along the eastern revenue boundary of village Landhari (Hadbast No. 140) and revenue boundary of village Chikanwas (Hadbast No. 144) upto point 'D' which is the south-east corner rectangle No. 63 of village Chikanwas (Hadbast No. 144) thence from point 'D' towards east along the northern boundary of rectangle No. 303, 302, 301 and 300 of village village Bir (Hadbast No. 145) upto point 'E' which is the north-east corner of rectangle No. 300 of village Bir (Hadbast No. 145) thence from point 'E' towards south along the eastern boundary of rectangle No. 300, 313, 353, 368, 411, 426, 469, 483, 526, 538, 581, 592, 633, 642, 683 and 695 of village Bir (Hadbast No. 145) upto point 'F' which is the south-east corner of rectangle No. 695 of village Bir (Hadbast No. 145).

South:-- Thence moving from point 'F' towards west along the boundary of additional controlled area-II, Hisar declared vide Haryana Government Gazette notification No. CCP(NCR)/HCA-F/Vol-III/2002/1300, dated the 1st July, 2002, published on dated the 9th July, 2002 upto point 'G' i.e. south-west corner of rectangle No. 689 of village Bir (Hadbast No. 145) and thence along the village revenue boundary of village Durjanpur (Hadbast No. 143) upto point 'H' which is the north-west corner of rectangle No. 119 of village Durjanpur (Hadbast No. 143).

West:-- Thence moving from point 'H' towards north along the western revenue boundary of village Durjanpur (Hadbast No. 143), village Chikanwas (Hadbast No. 144) and village Landhari (Hadbast No. 140) and boundary of rectangle No. 229 and 223 of village Agroha (Hadbast No. 54) upto point 'A' i.e. the point of start.
