No. CCP (NCR)/HSR/BWL-(CA)-2010/507 - Whereas in the opinion of the Government the area specified in the schedule given below and shown in the plan appended hereto has the potential for building activities and haphazard development ;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Punjab Scheduled Roads and Controlled Areas Restrictionn of Unregulated Development Act, 1963 (Punjab Act 41 of 1963), the Governor of Haryana hereby declares the said area to be a controlled area for the pusposes of the said Act, namely:-

Schedule

Schedule of boundaries of the controlled areas around Municipal Committee Limit Barwala, (Hadbast No. 128) Tehsil Barwala Distt. Hisar to be read with the Drawing No. DTP(H) 3432/2007 dated 22nd October, 2007/ 18th January,2008.

NORTH:

Starting from point 'A' i.e. north-west corner of rectangle No.1 of village Khedar (Hadbast No. 127) thence towards east along the west and north revenue boundaries village Issar Heri (Hadbast No. 126), village Bhari Badshapur (Hadbast No. 125), village Nawan Gaon (Hadbast No. 123) and village Gabipur (Hadbast No. 122) upto point 'B' i.e. north-east corner of rectangle No. 182 of village Gabipur (Hadbast No. 122).

EAST:

Thence moving from point 'B' towards south along the eastern revenue boundary of village Barwala (Hadbast No. 128) upto point 'C' i.e. the south-east corner of rectangle No.889 of village Barwala (Hadbast No. 128).

SOUTH:

Thence moving from point 'C' towards south-west and south-east revenue boundaries of village Barwala (Hadbast No. 128) village Sarsod (Hadbast No. 129) and village Bado Patti Doyam (Hadbast No. 68) upto point 'D' i.e south-east corner of rectangle No.69 of village Bado Patti Doyam (Hadbast No. 68).

WEST:

Thence moving from point 'D' towards north along the western revenue boundary of village Bado Patti Doyam (Hadbast No. 68), village Bado Patti Awal (Hadbast No. 69) and village Sarsod (Hadbast No. 129). Thence along the western boundary of rectangle No. 93, 91, 71, 69, 50, 47, 31, and 29 of village Jearo (Hadbast No. 132), thence along the western revenue boundaries of village Bichhpadi (Hadbast No. 131) and village Khedar(Hadbast No. 127) upto point 'A' i.e. point of start.
