**No. CCP (NCR)/KKR (LWA)/CA/A/2006/3932** - In exercise of the powers conferred by clause (a) of sub-section (1) of section 4 of the Punjab scheduled roads and Controlled Areas Restriction of Unregulated Development Act, 1963, (Punjab Act 41 of 1963), the Governor of Haryana, hereby declares the area within a distance of eight kilometers around the municipal committee limit Ladwa, district Kurukshetra as specified in the Schedule given below and shown in the plan appended hereto, to be a controlled area for the purpose of the said Act, namely:-

**Schedule**

Schedule of boundaries of the controlled area around the municipal committee limit Ladwa, district Kurukshetra should be read with Drawing No. DTP (KK) 889/05, dated 5<sup>th</sup> May, 2005/30<sup>th</sup> November, 2006.

North : Starting from point 'A' i.e. the north-west corner of rectangle No. 20 of village Nawarsi (hadbast No. 336), thence towards east along the northern boundary of rectangle no. 20, 19, 18 & 17 of village Nawarsi (Hadbast No. 336), thence towards north-east along the revenue boundary of village Garola (Hadbast No. 335) upto eastern boundary of revenue rasta of village Garola (Hadbast No. 335) to village Bhalari (Hadbast No. 216), thence towards north along the eastern boundary of this revenue rasta upto phirni of village Bhalari (Hadbast No. 216), thence towards east along the southern boundary of the Phirni of said village and the revenue rasta connecting village Bhalari (Hadbast No. 216) to Ladwa-Shahabad road up to western boundary of Ladwa-Shahabad road thence towards south-east along the western boundary of existing Ladwa-Shahabad road upto north-west corner of rectangle No. 46 of village Dhanaura (Hadbast No. 59), thence towards east along the northern boundary of rectangle No. 46, 45, 44, 43, and 42 of village Dhanaura (Hadbast No. 59) and rectangle No. 53, 54, 55, 56, 57 and 58 of village Bakali (Hadbast No. 58) and thence along the revenue boundary of village Bakali (Hadbast No. 58) upto point 'B' i.e. the trijunction of revenue boundaries of village Bakali (Hadbast No. 58), village Kheri Dabdlan (Hadbast No. 64) and village Samalkha (Hadbast No. 63).

East: Thence moving from point 'B' towards south-east along the north-east revenue boundaries of village Samalkha (Hadbast No. 63) and village Ban (Hadbast No. 62) upto north-east corner of rectangle No. 13 of village Ban (Hadbast No. 62), thence towards south along the eastern boundary of rectangle No. 13, 30, 36 and 543 upto eastern revenue boundary of village Ban (Hadbast No. 62), thence towards south along the eastern revenue boundaries of village Ban (Hadbast No. 62), village Budha (Hadbast No. 61), village Bapdi (Hadbast No. 75), up to the point 'C' which is the tri-junction of revenue boundaries of village Bapdi (Hadbast No. 75), village Baronda (Hadbast No. 72) and village Badarpur (Hadbast No. 69).

South : Thence moving from point 'C' towards west along revenue boundaries of village Bapdi (Hadbast No. 75), village Bapda (Hadbast No. 74), Village Lathi Dhanaura (Hadbast No. 73), and village Zainpur (Hadbast No. 78), upto the point 'D' i.e. the meeting point of the revenue boundaries of village Zainpur (Hadbast No. 78), village Baraut (Hadbast No. 81) and village Barhan (Hadbast No. 82).

West: Thence moving from point 'D' towards north-west along the south-west revenue boundaries of village Barhan (Hadbast No. 82) and village Bir Sonti (Hadbast No. 341). Upto south-west corner of rectangle No. 57 of village Bir Sonti (Hadbast No. 341). Thence towards north along the western boundary of rectangle No. 57, 45, 37, and 24 of village Bir Sonti (Hadbast No. 341) upto northern boundary of Kurukshetra-Ladwa Scheduled road, thence towards east along the northern boundary of Ladwa-Kurukshetra road upto the point where it meets the revenue boundary of village Nawarsi (Hadbast No. 336), thence towards north along revenue boundary of village Nawarsi (Hadbast No. 336) upto north-west corner of rectangle No. 40 of village Nawarsi (Hadbast No. 336) thence towards east

along the northern boundary of rectangle no. 40 of village Nawarsi (Hadbast No.336) upto its north-east corner, thence towards north along western boundary of rectangle no. 37, 29 and 20 of village nawarsi (Hadbast No. 336) upto point 'A' i.e. the point of start.
