No. CCP (NCR)/ KKR/-ALNG NH-1/CA/2009/3339:- Whereas in the opinion of the Government the area specified in the Scheduled given below and shown in the plan appended hereto has the potential for building activities and haphazard development;

Now, therefore, in exercise of the powers conferred by Sub-section (1) of section 4 of the Punjab Scheduled Roads and Controlled Area Restriction of Unregulated Development Act, 1963 (Punjab Act 41 of 1963), the Governor of Haryana hereby declares the said area to be a controlled area for the purpose of the said Act, namely:-

Schedule

Schedule of boundaries of the controlled area along the National Highway Number 1 (Shershah Suri Marg) in between additional controlled area of Kurukshetra and additional controlled area of Shahabad, District Kuruskhtra should be read with Drawing No. DTP (KKR) 948/09, dated 16th April, 2009.

Pocket II

North: Starting from point 'A' where it meets with eastern side of Delhi-Ambala railway line. Thence towards east along the already declared additional controlled area Shahabad published vide Haryana Government Gazette Notification No. CCP(NCR)KKR-CA-2/1620, dated 18th September, 1998 upto point 'B' i.e. the tri-junction point of revenue boundaries of villages Deeg (Hadbast number 118), Jandheri (Hadbast No. 240) and Chhapri (Hadbast No. 242).

East: Thence moving from point 'B' towards south along the eastern revenue boundaries of village Chhapri (Hadbast No. 242), Bakana (Hadbast No. 93). Thence along the eastern boundary of rectangle number 8, 10, 19, 23, 35, 41, 54 and 56 of village Machhrauli (Hadbast No.94). Thence along the revenue boundaries of village Chhapra (Hadbast No. 95), village Dudla (Hadbast No. 106) and village Koulapur (Hadbast No. 349) upto point 'C' i.e. the tri-junction point of revenue boundaries of village Koulapur (Hadbast No. 349) village Musapur (Hadbast No. 353) and village Ishergarh (Hadbast N0. 356)

South: Thence moving from point 'C' towards north-west along the additional controlled area boundary of Kurukshetra in Haryana Government Gazettee vide notification No. CCP (NCR)/2004/2593, dated 7th October, 2004 published on 19th October, 2004 upto point 'D' where it meets the eastern side of Delhi-Ambala railway line.

West: Thence moving from point 'D' towards north along the western side of Delhi-Ambala railway line upto point 'A' i.e. point of start
