Applications for grant of licence are hereby invited for setting up of Affordable Group Housing Colony as per provisions of the Haryana Development and Regulation of Urban Areas Act, 1975 and Rules framed thereunder as per the Affordable Housing Policy (PMAY)-2018 Notified on 06.12.2018 within Municipal Committee limits (Outside Core Area), within a **period of thirty days** from the date of publication of this public notice for the net planned area available in the residential sectors as per the list hosted on the website of the Department i.e. [www.tcpharyana.gov.in](http://www.tcpharyana.gov.in).
