

## OFFICE ORDER

**Subject: Transfer of record of the cases for grant of permission for change of land use and the connected matters falling within the jurisdiction of GMDA, to GMDA.**

Consequent upon the issuance of Haryana Ordinance No. 2 of 2017 vide notification dated 28.06.2017, Gurugram Metropolitan Development Authority has been established. The Haryana Vidhan Sabha in its recently concluded session, has passed the GMDA Bill. Order for attaching DTP, Gurugram and his staff with GMDA has been issued. Therefore, now as per Section 15 of Ordinance No. 2 of 2017, GMDA is to take action on the cases for grant of permission for change of land use falling within the jurisdiction of GMDA. GMDA has been separately requested to take action for issuance of notification for bringing into force Section 15 of Ordinance No. 2 of 2017 and also to depute staff of GMDA to collect the record pertaining to change of land use cases falling within the jurisdiction of GMDA, from this office. In view of it, it is hereby ordered that the entire record of the cases of grant of permission for change of land use and the connected matters be arranged in a manner for its shifting to the GMDA. A proper procedure for handing over the record to the officials of GMDA be followed.
