
Grant of permission for Change of land use - M/s Shiv Shakti Woolen Mills, Panipat.

Permission for change of land use for construction of Industrial building over an area measuring 7416.87 Sq. Yards falling in khasra No. 46//16,15/2 min of the revenue estate of village Ganjbar in controlled area, Panipat for setting up of S.S.I Unit for manufacturing of spinning Yarn is hereby granted on receipt of Rs. 37090/- on account of conversion charges .

2. This permission is further subject to the following terms and conditions:-
1. That the condition of the agreement executed by you with the Director, Town and Country Planning, Haryana, Chandigarh. and the provisions of Punjab Scheduled Roads and Controlled Areas Restriction of unregulated Development Act, 1963 and rules 1965 framed thereunder are duly complied with by you.
 2. That the additional amount of conversion charges for any variation in area at site shall be paid in lump sum with in 30 days as and when detected and demanded by Director, Town and Country Planning, Haryana, Chandigarh.
 3. That you shall give at least 75% employment to the domiciles of Haryana where the posts are not of technical nature and a quarterly statement indicating the category wise total employment and of those who belong to Haryana shall be furnished to the G,M/D.I.C, Panipat.
 4. That you shall submit the SSI / RIS registration of Industry department within 30 days from the date of issue of this letter .


5. That you shall pay External Development Charges in case of extension of urbanisable limit in agriculture zone and HUDA provides the services in this area and services are availed by you.
6. That you shall get the plans approved from the Director/ Authorized Officer before commencing any construction on the said land.
7. That this permission shall be valid for a period of two years from the date of issue of this letter subject to fulfillment of the terms and conditions of the permission granted and agreement executed.
8. This permission will not provide any immunity from any other Acts/ Rules/ Regulations applicable to the land in question.
