



The proposal for change in earlier approved Sector dividing Road of Sector-3 & 33, Sohna in the approved sectoral plan of sector 3, 4, 28, 29, 30, 31, 32, 33 & 34 of Sohna bearing drawing no. DTP (G) 2430/2020 dated 23.10.2020 has been approved in principle by the Government. A scanned copy of earlier approved sectoral plan bearing drawing no. DTP (G) 2346/2017 dated 05.06.2017 as well as proposed revised sectoral plan showing the re-alignment of Sector dividing Road of Sector-3 & 33, Sohna has been hosted on the departmental website.

In view of above, any land owner whose land is affected by this revision or any other person having any objection to the proposed revision of sectoral plan may file his objection in writing in the office of Senior Town Planner, Gurugram situated at HSVP Complex, Sector-14, Gurugram, within a period of 30 days from this notice. Senior Town Planner, Gurugram shall ensure the delivery of this notice to every land owner whose land is affected by the revised proposal.
