**SUBJECT: RECEIVING APPLICATIONS THROUGH ONLINE MODE ONLY.**

The Department has launched "e-Payments" to receive Online payments and "e-Compliance" to receive mandatory compliances against Rules 24, 26, 27 and 28 of the Haryana Development & regulation of Urban Area Rules 1976.

It has been decided that from 18.09.2017, all the payments shall be received in Online mode only. Also, the compliances against Rule 24, 26, 27 and 28 shall also be received in Online mode only from 18.09.2017 onwards.
